<b>DBS CHECK STATUS</b> Red Kite Thai Boxing teaches adults. Children are permitted to join only if they are either accompanied by a parent or guardian, or there is at least 1 instructor or volunteer with an enhanced DBS present. We encourage our instructors to obtain and maintain a current enhanced DBS. For enquiries about which volunteer members have an enhanced DBS, please contact a senior coach.

Red Kite Thai Boxing takes the safety of its members seriously. Several instructors are first aid trained to an acceptable standard and sufficient emergency first aid equipment is present at all classes and on site at all times. A risk assessment and associated health and safety briefs are conducted prior to classes commencing.

### FEES & CHARGES

Red Kite Thai Boxing does not have any hidden costs or dishonest fee collections in place. All money is payable by electronic payment/standing order/direct debit/ etc] when due, and receipts can be issued upon request.

Our club charges fees either by class or by monthly payment. These can be paid for either via the company website or via contactless payment. Monthly payments are expected to be paid on the 1<sup>st</sup> week of each month.

While we encourage students to pay via contactless card payment, in extreme circumstances in which a member is unable to do so via this method, we will accept a cash payment if they inform us before arriving.

You may discontinue training at any time.

### INDEPEDENCE STATUS

Red Kite Thai Boxing is legally independent and are not submitted to any compulsory regulation or obligation under any named associations.

Accordingly, it is our club's responsibility to comply with local and national laws / regulations, and there is no re-course to our representing organisation in the event of any breach of law, regulation or protocol. We retain the right to be an independent club and govern ourselves by best practice whether we are inside or outside the membership / affiliation of any governing bodies.

### REPORTING OUR CLUB
